With reference to the references cited above, I am directed to issue this order thereby communicating the continuation of the recognition for a period of one year, academic session 2020-2021, starting from July, 2020 and January, 2021 for offering only those programmes under ODL mode which were already recognised for the academic session 2019-2020 as under:



In the event of any Higher Educational Institution found offering programmes in Open and Distance mode and/or Online mode without recognition of the Commission or in violation to any of the provision(s) of these regulations and guidelines or orders made there under, the Commission may take actions as per Regulation 7 in Part -II of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and the Higher Educational Institution shall be solely responsible for career consequence of the students, if any, arising out of the same.
5. The other terms and conditions shall remain same as communicated in the previous Commission Orders.

Sub: Request from the AIU to extend the permission to offer ODL and/or Online Programmes for the period of two years for Higher Educational Institutions (HEIs)

Ref: AIU/Meet/ATR/354GC/2021 dated 04th August, 2021

Dear Madam,

With reference to the letter cited above, the following provisions have been incorporated in UGC (ODL Programmes and Online Programmes) Regulations, 2020 to allow more Higher Educational Institutions (HEIs) to offer Open and Distance Learning Programmes and Online Programmes in order to achieve the desired Gross Enrolment Ratio (GER) and to provide an enabling environment for the HEIs in higher education:

I. Relaxation in eligibility

(i) Eligibility criteria for offering Open and Distance Learning (ODL) programmes:

- The minimum requirement for National Assessment and Accreditation Council (NAAC) score has been brought down from 3.26 to 3.01.
- Additionally, HEIs having rank in top-100 in University category of National Institutional Ranking Framework (NIRF), at least once in two preceding cycles are also made eligible to offer ODL programmes.
- In view of unprecedented circumstances due to COVID-19 pandemic, 34 HEIs have been accorded continuation of recognition to offer programmes already recognized for the academic session 2019-2020, in Open and Distance Learning mode for a period of one year, academic session 2020-2021, starting from July 2020, as per Regulation 3(A) of UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020.

(ii) Eligibility criteria for offering Online programmes:

- Institution existence has been reduced to 3 years from 5 years.
- The mandatory eligibility of NAAC score of 3.26 and NIRF ranking atleast two in three preceding cycles has been relaxed as under:
 - The eligibility as per NAAC and NIRF is made optional instead of both being mandatory.
 - The minimum requirement for NAAC score has been brought down from 3.26 to 3.01.
 - Category of NIRF Ranking changed from rank in top-100 in "Overall Category" to "University Category".
 - Additionally, NIRF criteria has been changed to "at least once in two preceding cycles" instead of "at least two years during the previous three years".

2. Territorial Jurisdiction:

- Not applicable to Online programmes.
- Applicable to ODL programmes.
- HEIs having NAAC score of 3.26 and above or by the HEIs having rank in Top-100 in University category of National Institutional Ranking Framework (NIRF) at least twice in three preceding cycles can enrol International Learners.

3. Intake (non-science based programmes):


No limit on number of learners in a programme in ODL /Online mode.

4. HEIs having NAAC score 3.26 and above or having rank in Top-100 in University category of NIRF, at least twice in three preceding cycles (at the time of application) can start maximum 13 (3 Undergraduate + 10 Postgraduate) Online programme without prior approval of the UGC but in compliance to the Regulations.
5. 42 HEIs are entitled to offer 215 Online programmes from academic year 2020-21 and onwards and 68 HEIs (including Category-I HEIs) have been recognized to offer programmes through ODL mode for academic year 2020-21.
6. UGC has invited application from eligible HEIs as per provisions stipulated under (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 for recognition/entitlement of ODL and/or Online programmes for 2021-22, academic session beginning July, 2021 (revised as November, 2021) which are under process. It is informed that NAAC extended period has also been considered as an eligibility compliance.

You may also appreciate that with change in institutional eligibility requirements, many HEIs are now become eligible to offer ODL and/or Online Programmes. As there is no limit on number of enrolment/Intake; all the prospective learners have been provided an opportunity to enroll. The emphasis is to provide minimum benchmark centered eligibility so that quality distance and online education, in a global context, can be provided to National and International learners.

I look forward to your continuous support in enhancing the quality of distance and online education in the Country.
